GENERAL UPDATES



State Legislators Meet City Council

On Monday, October 13, the City Council held a Special Meeting with Senator Josh Becker and Assemblymember Patrick Ahrens, who provided updates on the 2025 legislative session. The discussion covered top legislative priorities followed by a Q&A session with Council. The City's lobbyist, Gonsalves and Son, commended the meeting as a positive step forward in strengthening relationships with local legislators.

"On housing, the Mayor drove home the need to allow the City time to catch up on the countless housing bills and their effects while pushing back on the introduction of additional legislation further eroding local control," City lobbyist Jason Gonsalves said. They further noted on Mayor and Council's "great job of engaging the legislators without challenging them and pushing towards an open and stronger partnership in the future." We appreciate the Senator and Assemblymember taking the time to attend this meeting.

22nd Annual Bay Area Diwali 2025 "Festival of Lights"

The Rise - Construction Begins

The Rise development (formerly, Vallco) began construction of onsite utilities and private roadways within the southern half of the property, west of Wolfe Road. The work includes utility connections in the public right-of-way and the construction of temporary driveway access to these private roadways along Wolfe Rd. The project has been issued a permit for this work. To date, the City has not received a permit application for vertical building construction.

This phase of work started on October 6 and is anticipated to be complete at the end of July 2026. As with any permitted construction, the project is responsible for meeting all permit conditions and inspections prior to final sign off of the building permit. The City will monitor erosion, sediment, and dust control measures throughout the duration of the work.


Oversized Vehicles Parking in Cupertino

On September 16, City Council approved amendments to existing municipal codes to address some parking problems. These changes will take effect on Friday, October 17th. Staff have been working together to install signs about new rules and educate the public with hopes of minimizing the need for issuance of citations.



Residents who own and use Oversized Vehicles (RVs, Trailers, and others) may apply for parking permits on the City's website: www.permitparking.cupertino.gov/.

FY 2025-2026 Property Tax Update

Taxable assessed property value in Cupertino increased from \$33.7 billion in fiscal year 2024–25 to \$34.9 billion in 2025–26, a 3.6% year-over-year rise, according to data from HdL Companies. The city's top 10 property owners account for \$10.2 billion, or 29.08% of the total assessed property value. Major property taxpayers include Apple, Main Street Cupertino, Vallco Property Owner LLC, Markham Apartments LP, and others. Explore HdL Property Tax Reports at cupertino.gov/budgetreport.

Invasive Aedes Mosquitoes Detected Close to Cupertino

The Aedes aegypti mosquito, an aggressive day-biter that can spread dengue and Zika, has been found near Hayes and Pruneridge Avenues, close to Cupertino. The County Mosquito and Vector Control District may treat the area if more are detected. Residents are encouraged to dump and scrub standing water weekly, including birdbaths, plant saucers and buckets.
