## Cupertino Receives \$184,000 Grant

The City is excited to announce that Cupertino Safe Routes to School is receiving a grant from the California Office of Traffic Safety (OTS) for Bicycle and Pedestrian Education Program for a second year! The grant, which runs through September 2026, offsets all of the budgeted City general fund dollars for our traffic safety education program for pedestrians and bicyclists in Cupertino schools ages K-8.



Grant funds will continue to support various activities focused on bicycle and pedestrian safety:

- Pedestrian training courses that educate youth on safe walking behaviors.
- Bicycle training courses that educate youth on safe riding behaviors.
- Helmet fitting inspections and distribution of helmets to children in need.
- Community and school education presentations.

This grant is funded by the California Office of Traffic Safety through the National Highway Traffic Safety Administration. We are very grateful and excited to work with OTS another year.

## Silicon Valley Clean Energy Board Updates




As 2025 comes to a close, the Silicon Valley Clean Energy (SVCE) Board held two meetings last week to prepare for 2026. The Board received an informational update on the growing impact of data centers, including emerging AI-related facilities, and the implications for energy demand forecasting, grid capacity, and affordability. Staff will continue monitoring these developments to minimize risk and protect existing customers.

The Board also set direction for 2026 electric generation rates, voting to maintain a one percent discount compared to PG&E rates and approving a monthly bill credit to California Alternate Rates for Energy (CARE) and Family Electric Rate Assistance (FERA) customers. Overall customer bills are expected to decrease slightly in 2026 due to lower energy market prices.


## Weather Advisory: Heavy Rainfall Expected

Rain is expected daily from Saturday, December 20 through Thursday, December 25, as an atmospheric river moves through the region. Track power outages with [PG&E's online tools](#), check stream and reservoir levels with [Valley Water](#), and get updated weather forecasts with the [National Weather Service](#). ## Stevens Creek Blvd Class IV Bike Lane Phase 2A Project

### Stevens Creek Boulevard Class IV Bikeways



Construction begins on Phase 2A of the Stevens Creek Boulevard Bike Lane Project! Work starts on Monday, January 5, and is expected to wrap up by the summer. Expect some traffic delays in the area during construction. This project will modify the stretch of Stevens Creek Boulevard between Wolfe Road and De Anza Boulevard, turning the current buffered bike lanes into protected bike lanes with concrete barriers separating bikes from cars.

New bike signals will also be added at the Wolfe Road and De Anza Boulevard intersection. More details are available on the [project website](#).



## Women's Business Luncheon

On Thursday, December 18, the City of Cupertino, in partnership with the Cupertino Chamber of Commerce and KeyPoint Credit Union, hosted another Women in Business Symposium Luncheon. The event brought together entrepreneurs and small business owners to exchange ideas and gain insights on navigating the age of artificial intelligence and mastering the art of the elevator pitch. Mayor Kitty Moore attended and delivered opening remarks, and Councilmember Sheila Mohan was also present, along with Interim Deputy City Manager Kirsten Squarcia and Economic Development Manager Daniel Degu. Resource partners such as NOVAworks and SCORE were present at the event, offering materials and information for attendees.

## Cupertino Business Outreach

On Monday, December 15, 2025, City staff visited local businesses at the APN Plaza and Stevens Creek Center shopping centers as part of the City's Cupertino Business Outreach Program (CBOP). During the visits, staff connected with several businesses, including Panera Bread, Voyager Craft Coffee, Aiko Skin & Body, and Dr. ink, a new business that opened at the end of November.



## Farmers Market Meeting

On Monday, December 15, City staff met with the Pacific Coast Farmers' Market Association (PCFMA), the organization that operates the farmers market at De Anza College and Creekside Park. The meeting included a general discussion about their two markets, and PCFMA expressed interest in learning more about upcoming City events.


### De Anza State of the College Presentation
