## NOTEWORTHY UPDATES

### Cupertino Chamber Board Installation

Yesterday I attended the Cupertino Chamber of Commerce 2026 Board Installation and Reception at Cupertino Community Hall, celebrating the installation of the new Board of Directors. Business leaders, chamber members, community partners, and elected officials gathered for an evening of connection and recognition, marking the start of a new year of leadership and collaboration for the Chamber. Mayor Moore led the Pledge of Allegiance and provided opening remarks. Councilmembers Mohan, Fruen, and Wang, along with Economic Development Manager Daniel Degu also attended the event.



### Santa Clara County City Managers Association Meeting



On Wednesday, I attended the first Santa Clara County City Managers Association (SCCCMA) meeting of 2026. City Managers in attendance discussed shared challenges and priorities, reviewed the 2026 meeting calendar and committee assignments, and received updates on regional initiatives including development services, countywide medical services coordination, and leadership development efforts.

### Cupertino Business Outreach Program

This week, City staff visited several local businesses as part of the City's Cupertino Business Outreach Program (CBOP). During the outing, staff visited the Homestead Square Shopping Center connecting with several businesses, including Starbucks, PGA Super Store, and Fish is Wild, to share available City resources and support opportunities. Additionally, staff recently met with the new owners of Local Kitchens: 21666 Stevens Creek Boulevard.



### Preferred Bank Tenant Improvement Project



Building plans have been submitted for tenant improvements at 20803 Stevens Creek Boulevard. The space, totaling 3,280 square feet, has been vacant since 2019 and was last occupied by The Vitamin Shoppe. The new tenant, Preferred Bank, plans to occupy the space. The project valuation listed in the application is \$493,411.

## RECAP MEETING AND RESIDENT CONCERNS

### Silicon Valley Chinese School Class with City Staff

On Tuesday, January 13, Silicon Valley Chinese School (SVCS) kicked off its Mandarin language classes for City staff during lunchtime. The voluntary enrichment program provides an opportunity for interested employees to participate on their own time. Mayor Moore and Vice Mayor Chao both participated in the kickoff session, which also included traditional Taiwanese-style refreshments to celebrate the launch.

### City Hall Tour with Councilmembers And Commissioners

On January 12 and 13, Public Works staff provided tours of City Hall for Councilmembers and Planning Commissioners. The walkthrough highlighted several key facility conditions and layout considerations, including the large lobby, former Council Chambers, HVAC areas, lower-level storage, limited natural light in interior spaces, low ceiling heights on the lower level, and elevator issues.

### Council Prep Session: Dividend Homes Project

On January 15, 2026, Councilmembers met with Community Development staff for a prep session on the Dividend Homes Project, which is scheduled for discussion at the January 21 City Council meeting.
