# Rules for Riding in a Group

## **Ride on the right side of the road**

Make sure you and your child do not ride into oncoming traffic.

## **Avoid the door zone**

Stay at least 3 feet from parked cars to avoid any doors that open.

## **Create space between riders**

Keep your front wheel behind the back wheel of the person in front of you.

## **At signalized intersections, obey the signal**

STOP if the light is red, yellow, or “stale” green (it’s been green so long that it will turn yellow any second), even if it separates you from your group.

## **Use hand signals**

Signal right, left, or stop before turning or stopping.
