9/22	C5	Grand Theft	Between 9/17 and 9/18, unknown suspect(s) stole an unlocked bicycle from a reception area at an Apple office building on N. Tantau Avenue for a total loss valued at approximately \$1,100.
9/22	C4	Theft by False Pretenses	On 9/22, the victim reported unknown suspect(s) befriended the victim online and ultimately convinced the victim to mail a \$30,000 check to the suspect(s). The victim lives in Cupertino.
9/22	C7	Identity Theft	On 9/22, the victim reported unknown suspect(s) used the victim's personal information to access the victim's credit card account and made fraudulent purchases totaling approximately \$891. The victim lives in Cupertino.

The suspects were in possession of stolen mail containing personal identifying information that did not belong to either suspect. One suspect was also in possession of burglary tools, the other suspect provided deputies with false identifying information, and both violated probation terms. They were arrested and booked into the Main Jail.

9/23	C9	Kidnapping, False Imprisonment, Aggravated Assault	At 3:50 PM, two suspects deprived the victim of his liberty at Cupertino High School on Finch Avenue, moved the victim to another area of the school, and assaulted him, causing injuries. Both suspects are known and at large.
