
#### GENERAL UPDATES

## Q1 2025 Sales Tax Update

The City receives quarterly sales tax data from HDL. Q1 of 2025 indicates year-over-year growth in multiple sectors such as Casual Dining, Service Stations, Grocery Stores, Specialty Stores, Sporting Goods/Bike Stores, and Garden/Agricultural Supplies. # Permanente Creek Restoration Project Breaking Ground

On July 22, Heidelberg Materials and Santa Clara County District 5 Supervisor Margaret Abe-Koga hosted a groundbreaking event to celebrate the start of the multi-million-dollar Permanente Creek Restoration Project. The event marked a significant milestone in efforts to enhance the natural environment and restore local ecosystems.

#### **Encroachment Permit for The Rise**

The City is processing an encroachment permit to be issued this week associated with The Rise development (formerly Vallco Town Center). The work involves moving PG&E and Verizon utility vaults and conduits along Wolfe Road, north of Vallco Parkway, to prepare for future roadway improvements as part of the project.



Work is scheduled to start Monday, July 28 and will continue for about 20 weekdays, from 9:30 a.m. to 3:30 p.m. Four street trees will be removed to facilitate vault and utility work, but the City is working to minimize removals and preserve as many trees as possible, limiting any loss to areas directly affected by construction. Replacement trees will be provided as part of future offsite improvements.



## West Valley Community Services Town Hall

On July 24, Councilmember J.R. Fruen and Councilmember Sheila Mohan joined a community Town Hall hosted by West Valley Community Services, in collaboration with Assemblymember Patrick Ahrens and with participation from Supervisor Margaret Abe-Koga.

The event marked the official launch of West Valley's new strategic goals and featured discussions on key policy initiatives at the state level, with potential implications federally. The Town Hall also served as a forum to begin developing collaborative, community-driven solutions.

### **New Control Room**

The control room renovation project at Community Hall officially began on Wednesday, July 23. Our team and contractors are working in staggered shifts, six days a week, with extended 11-hour workdays to ensure steady progress through—and beyond—the first Council meeting scheduled for September 3.

This is a complex, multi-phase initiative that includes constructing an entirely new control room in the building's back office, installing upgraded lighting systems, implementing a modernized electronic voting system, updating the dais infrastructure, and completing several other critical AV and infrastructure improvements.

Given the scope and pace of the project, we're committed to maintaining clear timelines while minimizing disruption to regular City operations.



# **2026 Major Sporting Events**

City staff are attending monthly planning calls with regional, federal, and sporting partners, including the Bay Area Host Committee, to align planning efforts for major events in 2026. Ongoing coordination helps ensure a clear understanding of regional happenings and any opportunities for the City to participate.

# Quiet Paddle Request Begins August 1

To balance recreational use with neighborhood quiet hours, the City is requesting the use of quiet pickleball equipment starting August 1.

Pickleball players are encouraged to use USA Pickleball-certified quiet paddles and balls during designated quiet times: from dawn to 9 a.m. and 7 p.m. to 9 p.m. daily.



Other mitigation methods are also underway. Signage will be posted at courts to support this effort, which aims to reduce noise during early morning and evening hours while preserving access to the sport. Public outreach is currently underway. # City Hall Parking Lot Painting Phase 1

City's Streets Division will begin Phase 1 of re-striping the City Hall parking lot on Tuesday, July 29, from 5 a.m. to 11 a.m. This work will refresh stall lines and markings in the designated orange areas (as shown in image). Any vehicles parked in this area must be moved to the green areas by Monday evening. Signage will be posted starting Friday, July 25, to notify employees and visitors of the upcoming work.

## New SB 330 Preliminary Application Submitted for Bandley Drive Site

On July 15, the City received a new SB 330 Preliminary Application for a proposed housing development application located at 10268 Bandley Drive. The applicant, Summerhill Homes, anticipates proposing to remove the existing office building to construct a three-story townhome development with 27 new residential units (including 5 affordable units) on a 1.55-acre lot. The site, which is not on a Priority Housing Element site, currently houses multiple commercial office tenants. The applicant intends to utilize State Density Bonus Law which allows additional market rate units for the provision of affordable units, waivers to development standards, and incentives/concessions to reduce costs to provide housing. # Lehigh Quarry Public Meeting

The meeting will share key information, and offer residents an opportunity to ask questions and voice their concerns. The meeting will occur on Thursday, July 31, from 6:30 to 8:30 p.m. at Quinlan Community Center.

# Tenant Relocation Meeting for McClellan Terrace Residents

On Tuesday, July 8, Interim Deputy City Manager Kirsten Squarcia attended a community meeting regarding tenant relocation services for McClellan Terrace residents. The meeting was hosted by OPC (a TranSystems Company), which will be responsible for facilitating the relocation process. Volz Company and Prometheus were also listed as hosts, but representatives from those organizations were not in attendance. The relocation process is being undertaken due to the acquisition of the property by the Foothill-De Anza Community College District (FHDA), which intends to convert the site into student housing. Below is a summary of the information shared by OPC:

- Interviews are currently being conducted with all households to gather information on household size, income, and other relevant details.
- Once completed, the relocation plan will be made available to all project households for a 30-day review and comment period.
- The relocation plan is scheduled to be presented to the Foothill-De Anza College District Board for approval in Fall 2025.
- After board approval, OPC staff will begin reaching out to collect documentation confirming household identification and income.
- Once documentation is submitted, individual household benefits will be calculated based on each household's specific circumstances.
- Notices of Eligibility will be issued to households starting in January 2026.
- Residents are advised not to move out of the community until they receive a Notice of Eligibility.
- The site is expected to be fully vacated by June 2026.

## Finch Property Timeline Update

The City is currently conducting due diligence on the Finch Avenue property, which is expected to take 6–8 weeks. CUSD is anticipated to bring the item to its Board in August to appoint negotiators. Once due diligence is complete and negotiators are in place, the City expects to begin discussions in the fall.

# **Meeting with Audit Commission Chair**

On Monday, I met with Audit Commission Chair Eno Schmidt for a productive conversation on broad municipal topics. With the next Audit Commission meeting scheduled for July 28, we also reviewed current commission activities and priorities. It was a valuable discussion, providing helpful insights into ongoing and upcoming City matters.

# Meeting with AlphaX RE Capital

On July 24, Mayor Chao met with representatives from Alpha X, a women-founded real estate company based in Cupertino. During the meeting, Alpha X shared their perspective on the permitting process for Accessory Dwelling Units (ADUs) in Cupertino and other cities. Alpha X also highlighted state legislation pertaining to ADUs such as Assembly Bill 1033, Senate Bill 9, and Senate Bill 1123. Mayor Chao was joined by Economic Development Manager Daniel Degu.

# **Food Network Quarterly Meeting**

On July 25, Block Leader Coordinator Marta Drown attended the Food Network Quarterly Meeting on my behalf. This meeting is part of a bigger effort to help organizations quickly find and share information, work together, and communicate before, during, and after disasters, while also helping local governments share important disaster information. The agenda included a look at the Food Network's mission and tools, a discussion about training and planning needs for disaster readiness, and a roundtable where organizations shared updates to improve coordination. Overall, this collaborative approach helps ensure that everyone will be better prepared to respond and support the community during emergencies.

# Residential Burglary Arrest and Property Recovery

On June 20, a residential burglary occurred on the 10000 block of Empire Avenue. Suspects broke into a residence and stole nearly \$18,000 in jewelry and two Porsche vehicles. The vehicles were then used by the suspects in a crime spree.

Thanks to the efforts of law enforcement, the three suspects were located in a San Jose Hotel and both vehicles have been recovered along with most of the jewelry. Also found in the suspects' possession were stolen mail and materials related to identity theft. # Input on Non-Resident and Special Interest Groups

Concerns were raised about non-residents and special interest groups meeting with City staff on issues that may impact local infrastructure, quality of life, and service availability for Cupertino residents. In response, I shared that while staff may occasionally coordinate with individuals and organizations beyond City boundaries, all such interactions follow professional standards and transparent processes, including public noticing and Council oversight where appropriate. Staff is mindful of how time and engagement are perceived.
